Hello again friends and lovers of Saline Valley. Another year has passed since we have published a newsletter, so we'd like to bring you up to date on the happenings affecting Saline Valley and organizational developments. It's been a busy and eventful year for both Death Valley National Park and for SPA.

## NEW DVNP SUPERINTENDENT

Mrs. Sarah Craighead has taken her position as Superintendent of Death Valley National Park following the retirement of J.T. Reynolds at the end of 2008. Mrs. Craighead comes to Death Valley after serving as Superintendent of Saguaro National Park. She has been getting familiar with the very large territory under her supervision and is focusing on bringing the infrastructure of the Park up to date, including recently initiated road improvement projects in the main section of the Park. Our camp host has visited with Mrs. Craighead in Furnace Creek, but the Superintendent has not had occasion to visit the Saline Valley or the Springs to date. SPA welcomes the new Superintendent and the Board looks forward to meeting her and establishing a positive and cooperative working relationship.

## CAMP FUNDS HELD BY DVNP

SPA is very interested in the existence and disposition of the fund for support of Saline Warm Springs established by Superintendent Reynolds. We were told that Saline Valley visitors donated approximately \$800 to this fund, but none of it was ever provided by DVNP for the support of the Camp Host or necessary supplies for the maintenance of the Spring's camp sites. Since it was only the personal word of Superintendent Reynolds that secured the donations to this fund for use in Saline Valley, it may be that this money has been pre-empted for use in the park generally, or for administrative costs for Saline Valley rather than maintenance of camp site conditions. If these monies were used for things like more frequent pumping of latrine facilities, no notice of that has been provided to the Camp Host. The latrine facilities were pumped out in early May, a very timely procedure after a winter's worth of visitor use. If you donated to this fund, you might write to Mrs. Craighead to ask for an accounting of how this money was or will be utilized. ## **New Desert Protection Act**

The Desert Protection Act of 2010, sponsored by Dianne Feinstein, was passed recently. This bill adds about 41,000 acres to the park and validates the “Wilderness Restoration” activities that have been being carried out in recent years. These activities primarily resulted in closing pre-existing roads within the park that allowed access to remote sites by vehicle. This has closed sites previously enjoyed by many within the park to anyone not able to walk with weight. The one good part of this bill is that it gives the Inyo County Road Department access to the borrow pits located along the Saline Valley Road for road maintenance work, which SPA has been urging DVNP to allow.

DVNP recently requested input from the public on management of its backcountry lands, but stated that the Saline Valley Warm Springs area would be handled separately at some time in the future. SPA is maintaining vigilance on this planning effort and will participate as allowed at the appropriate time. Information was recently released regarding a Memorandum of Understanding (MOU) reached between Inyo County and DVNP to cooperate in the process of planning for backcountry management and administration. Inyo County Board of Supervisors will appoint one staff member to participate in this planning process and SPA will make an effort to communicate our concerns regarding Saline Valley policies and administration to this individual as well.

The forum was very handy for many potential President’s Day visitors in February as actual up-to-the-minute conditions encountered by travelers were posted, (with pictures), for the consideration of others wishing to try the trip.

As a result of the development of our website, we are making the announcement now that we will be moving toward an e-mail/website-only format for “The Source” in the near future. We will post news updates on the website and even send notice of new editions of “The Source” to SPA members by e-mail only. So we need to ask here that you send us your e-mail address, along with a first and last name and current mailing address (for identification purposes). We will need this information for each person wishing to be registered as a voting member of SPA. Registering as a Forum participant on our website is not a valid SPA membership registration. If you are not e-mail capable, we hope that you may have a friend who is, and is also a SPA member, who can print and mail you a copy. Another alternative is to use your local public library facilities to access SPA’s website. We will continue to carry persons without an e-mail address as registered SPA members, but do not foresee being able to produce and distribute hard copies of “The Source”. All personal identification information will be kept completely confidential.

## ***SPA Bylaws Revision***

SPA has recently reorganized with the nomination to our Board of Directors Tom Ganner, a past Saline Warm Springs Camp Host, and Nevada resident Rick Brower. Tom and Rick replaced retiring members Sherry Cosgrove and North Swanson. They join current Directors Patricia Wilder-Barton of Bishop, John Dukes of Keeler and Timbo Hynes of Lancaster. We have re-established a local area mailing address for SPA, (P.O. Box 136, Keeler, CA 93530) and revised our Bylaws and Mission Statement. We are required to call for a membership vote on all Bylaws revisions. Please review our revised bylaws at <http://www.salinepreservation.org/bylaws.htm>. Members may vote to accept or reject this document electronically by sending an e-mail to [Abylaws@salinepreservation.org](mailto:Abylaws@salinepreservation.org) if you accept the proposed revisions, or [Rbylaws@salinepreservation.org](mailto:Rbylaws@salinepreservation.org) if you reject it. This e-mail must include your first and last name and your street mail address for membership verification purposes. We would ask that SPA members submit their vote within 30 days of receipt of this newsletter, which is the minimum stipulated in the attached Bylaws.

## ***SPA Business Information***

After print and mail costs for this issue of the Source, we are left with a balance of approximately \$3500. Membership had been declining gradually over time as old-timers visited less often and newer visitors were not aware of SPA's existence. We have, however, seen a marked increase in visitors registering as SPA members in recent months. The new SPA website has undoubtedly been a primary stimulus for the greater public awareness of SPA as an organization, as has SPA's Board of Directors now being composed of members who are able to be frequent visitors to Saline Warm Springs, establishing a greater on-site presence. SPA has received quite a few donations in recent months, and we would like to express our sincere gratitude for this generosity and support for our efforts on behalf of the Saline Valley and its devoted visitor community.

## ***Saline Warm Springs Needs***

A place has been established on SPA's website for camp needs to be posted and discussed by visitors and website users. In cooperation with the Camp Host, SPA is providing funds for, and securing, several items needed at Saline Warm Springs campsite. New cleaning brushes were provided recently. A new canopy for the Crystal Pool at Lower Warm Spring was also recently provided and installed, and new joists and screws are being obtained for maintenance of the deck on the lawn at the Lower Warm Spring. If you have a thought as to something needed at Saline Warm Springs for enhanced visitor comfort or convenience or operational efficiency, please let us know and we'll see what can be done in cooperation with the Camp Host.
